## Returning AFGUARD® EWS for Recertification Instructions



Please follow the instructions below for quick processing of your return request:

- 1. For presentation to the designated carrier and customs, use the proforma invoice form in Appendix 1. This document must be sent to our shipping department (versand@faudi-aviation.com) for review and confirmation in advance of any shipment.
- 2. Pack the goods completely and securely for transport. Use only the robust AFGUARD® custom case provided by FAUDI Aviation¹. The AFGUARD® EWS is equipped with a cover over the sensitive front part as standard.
  If the case and/or cover is lost, please contact your local distributor to order a replacement. Any AFGUARD® EWS that arrives in different packaging will be returned in a new FAUDI Aviation certified package at the sender's expense.
- 3. Any possible contamination of equipment and components must be communicated by sending the following "Declaration of Contamination" form in Appendix 2 together with the AFGUARD® EWS to be recertified.

Additional costs for shipping and/or customs clearance and/or incurred by not following the return process specified by FAUDI Aviation will be added to the recertification costs.
